Privacy Policy

Introduction

For the purposes of this Privacy Policy (the "Policy"), the terms "AXA IM", "We", and "we" collectively refer to AXA Investment Managers Asia (Singapore) Ltd. ("AXA IM Asia") or its holding company, subsidiaries and affiliates.

We respect your privacy and understand that your privacy is important to you. This Privacy Policy summarizes how AXA IM Asia collects, uses, and discloses personal information that you may enter on this Website (defined below).

We are committed to maintain your personal data in accordance with the requirements of the Privacy Act 1988 (Cth), and will take all reasonable steps to ensure that your personal data is kept secure against unauthorised access, loss, disclosure and destruction.

Scope

This Privacy Policy applies only to the website located at <http://www.axa-im.com.au> (the "Home Page") and any webpages accessible that do not indicate that the user is leaving (or has left) the "AXA IM Asia" website (collectively, the "Website").

Purposes of Collecting Personal Information

The information we collect during normal usage of the Website may include your Internet address, the name and version of your Internet browser, the website that referred you to the Website, the pages on the Website you view and/or request, and the date and time of those views and/or requests. We may use this information to generate statistics and measure site activity to improve the usefulness of user visits. During normal website usage, we do not collect or store personally identifiable information, including but not limited to, your name, company name, telephone number and email address.

However, there may be instances on the Website where you are asked to submit your personal information such as name, e-mail address, phone number, and/or comments in order for you to contact us. We will only collect, use or disclose your personal information as reasonably necessary for the purpose of addressing your enquiry, internal training and such other purposes as permitted by law. Generally, we will not collect sensitive information about you (such as your race, political beliefs, religion or health) unless this is required for the aforesaid purposes. If we need sensitive information, we will ask for your consent when we collect this information (unless an exception applies). If you do not provide us with all or part of the information requested we may not be able to address your request or inquiry. We shall not use such information for any purpose other than the aforementioned ones. We do not intend to use your personal data in direct marketing. We may record incoming and/or outgoing telephone calls to address your enquiry or for internal training purpose. If you require access to a recorded call, a copy or appropriate access will be provided by us where available. It should be noted that not all calls are recorded and therefore not all calls will be accessible upon request.

Please note that AXA IM is not obligated to respond to inquiries submitted through the Website.

Opt Out Statement

It is not mandatory for you to disclose your personal information to us. In the event that you do not provide such personal information, we may not be able to provide you with our products or services.

Confidentiality and Disclosure

We will keep any personal data held by us confidential. AXA IM Asia may disclose your personal information to the authorised personnel of each of AXA IM entities located overseas or its professional advisors (on a need-to-know basis) for the abovementioned purpose.

Any personal information collected as a result of such user submissions will not be provided to any non-AXA IM company for their personal or business use.

No personal information will be disclosed to any unauthorised personnel unless they are required by law to be disclosed.

We will only use, store, and/or disclose such personal information provided by you through this Website in a manner consistent with applicable laws or regulations.

Data collected may be maintained for such period as may be required under applicable laws.
